1. Membership to Top Croppers® can begin anytime. Points are earned from the day the registration form is submitted.
2. All claims must be verified by proof of purchase (copies of invoices are required if a Retailer does not upload electronically).
3. The purchase of products listed in the Qualifying Products table made between 1 July and 30 June are eligible for Rewards Points. Participants must send in their manual Claim Form and invoices by 31 July and/or claim online by the advertised date.
4. Reward Points may only be redeemed by the registered Top Croppers member and are not transferable.
5. Rewards can only be redeemed during the advertised Redemption Period.
6. Rewards Points are earned for purchases made within the specified Purchase Period (1 July – 30 June) and are not valid after the period's closing date.
